The Player acknowledges that he has selected the Agent and conducted all due diligence required to do so, and that the MLBPA has no liability to the Player based on its certification of the Agent or the Agent's conduct. Player and Agent agree to hold harmless the MLBPA, its officers, employees and representatives from any liability, damages or costs relating to this Designation.
