



Declaration by Applicant for MLBPA Agent Certification

By my signature below, I hereby certify that I have read the Regulations Governing Player Agents ("Agent Regulations") of the Major League Baseball Players Association (MLBPA) and I understand and agree that I will comply with and be bound by those Agent Regulations and any subsequent amendments to the Agent Regulations that may be adopted by the MLBPA, including but not limited to the Exclusive Arbitration Procedures for Resolving Disputes set forth in the Agent Regulations. I agree that any dispute between an Applicant and the MLBPA related to the application and Certification process, including without limitation any dispute about whether the Applicant, Agent or Advisor must provide documents, testimony or other information to the MLBPA or about whether such documents, testimony or information are privileged, is subject exclusively to arbitration under Section 7(B) of the Agent Regulations. In addition, I agree that that if I am aggrieved in any way by an action taken by the MLBPA, including but not limited to a denial of certification or conditions imposed on a certification, I may appeal exclusively to arbitration under Section 7(B) of the Agent Regulations.

I further agree that my failure to comply in any material respect with any provision of the Regulations shall constitute grounds for denial, revocation, limitation or suspension of my certification, or other disciplinary action by the MLBPA. I also certify that I have read my Application, have personally answered the questions in it, and the answers to those questions are true to the best of my knowledge, information and belief. I understand and agree that any misrepresentations, false or misleading statements, or omissions of a material nature in my Application as well as any failure to cooperate with the MLBPA in its processing of my Application, or with any investigation conducted by the MLBPA shall constitute grounds for denial, revocation, limitation or suspension of my certification, or other disciplinary action by the MLBPA.
